Related to that, I don't know how long б 7 Mr. Blanche's cross-examination will be, but I think that 8 it's highly likely that we will get to the defense case, 9 such as it is, on Thursday. 10 And we don't know who the defense witnesses are, except for an expert witness and potentially Mr. Trump. 11 12 They've indicated that the only other witnesses 13 that they intend to call are impeachment witnesses. Under 245.20 (4)(b), we are entitled to know that 14 15 at the end of whatever witness' testimony they are seeking 16 to impeach. 17 So I understand that we haven't gotten there yet with Michael Cohen, but if there are any other impeachment 18 19 witnesses that they intend to call to impeach one or other 20 of our witnesses, we would like to know who those witnesses 21 are. 22 I think we're entitled to know who they are. Also, for planning purposes, we are entitled to 23 24 have our potential rebuttal expert present for any expert 25 testimony that they may proffer on their case.

3506 1 And so, we would like to know when the expert will testify so that we can make -- our expert is not local, so 2 3 we can make travel arrangements, so that we don't have to 4 have an unnecessary delay. 5 THE COURT: Okay. MR. BLANCHE: All fair. б 7 We do not have any rebuttal witnesses as of now. 8 THE COURT: You don't have any? 9 MR. BLANCHE: We do not have any rebuttal witnesses 10 as of now, pending the testimony of Mr. Cohen. 11 I believe the cross will continue until the end of the day Thursday. 12 If it even finishes, it will be very near the end 13 14 of the day and presumably there will be redirect. 15 As for our expert, we have communicated with him 16 and expect him to be here over the weekend. 17 But whether we call him depends, in part, on the charge -- we submitted the charge, just this morning, so I 18 know you haven't read it yet. 19 And so, what we would hope to be able to do is to 20 21 at least have some discussion about that before we begin our 22 case, presumably, on Monday. Because, depending on the ruling, we may not call 23 24 him. 25 THE COURT: That's a little tricky. I have to go



Kind, humble, genuine; correct? 23 Q 24 Yes, sir. Α 25 The same question I asked you before. When you said Q

Now, moving a little bit forward to 2017, do you 4 0 5 recall a Vanity Fair profile that was done about you in 2017, б in September? 7 I'm sorry. Can you repeat that? Α 8 Sorry. Q 9 Do you recall a Vanity Fair profile that was done in September of 2017? 10 Α I do. 11 12 And do you remember saying -- and that was an article Ο 13 that you participated in; right? Written by Emily Jane Fox. 14 Α And you said that you were the guy that stops the 15 0 16 leaks, talking about who you were as it relates to President Trump; correct? 17 18 Α Correct. 19 And you said that you were the guy who protects the 0 20 the President and the family; right? I believe so. 21 Α 22 0 Excuse me? 23 Α I believe so, yes. 24 And you also said at that point that you would take a 0 25 bullet for the President?

3692 1 Α I did say that, yes. 2 0 You also talked about, at that time -- and, again, 3 this is September 2017. You said that towards the end of the 4 campaign, that you were offered book deals; correct? 5 Α I was offered a book deal, yes. б So, you were offered -- I believe you said you were 0 7 offered \$10 million to write a tell-all book; is that right? 8 Α I believe so, yes. 9 And you said that -- what you said in the article is Q that your counteroffer was, "How about a hundred million?"; 10 correct? 11 12 Α Correct. 13 According to the article, at the time, there was no 0 number that worked for you; right? 14 That's correct. 15 Α 16 0 You -- you were just pushing them to see how high they 17 would go in a book offer; right? That includes the reading or the 11 listening to the reading of any transcripts of the trial or the reading of any posts on any court sites. 12 Do not attempt to research any fact, issue or law 13 14 related to the case. 15 Do not communicate with anyone about the case by 16 any means, including by telephone, text messages, email or 17 the internet. 18 Do not Google or otherwise search for any information about the case or the law which applies to the 19 case or the people involved in the case. 20 21 I will see you Thursday at 9:30. 22 (Jury leaving courtroom.) * * * 23 24 THE COURT: You may be seated. 25 Sir, you can step down.
